

### **PUPIL PREMIUM POLICY**

#### 2022-2026

At St Vincent's RC Primary School, we believe that all our children have an equal entitlement and should have an equal opportunity to:

- · Develop imagination and creativity
- Acquire skills and abilities
- Have a love of learning

The school receives funding from the Government to support it in trying to meet these aspirations. This is known as the Pupil Premium Fund.

Pupil premium is additional funding, from the government, provided to schools for supporting pupils from low income families to ensure they benefit from the same opportunities as all other children in reaching their full potential. There are four categories of children that qualify for pupil premium:

- Children who are eligible for Free School Meals
- Children who have been eligible for free school meals at any time during the past 6 years (FSM6)
- Children who are looked after
- Service Children

It is for schools to decide how the Pupil Premium funding is spent, since they are best placed to assess what additional provision should be made for the individual pupils for whom they are responsible. The Pupil Premium funding is allocated to schools based on the number of pupils who qualify for Pupil Premium according to the January school census data.

In 2023-2024 each child eligible for Pupil Premium funding attracted £1,455 under the Deprivation Pupil Premium, £2,530 under the LAC/Post LAC Pupil Premium and £335under the Service Child Grants.

Schools have the freedom to spend the Premium, which is additional to the underlying schools budget, in a way they think will best support the raising of attainment and aspirations of the most vulnerable pupils.

At present 19.84% of the children at St Vincent's RC primary School are eligible for Pupil Premium funding. All our staff and governors accept responsibility for 'socially disadvantaged' pupils and are committed to meeting their pastoral, social and academic needs within a caring environment. The targeted and strategic use of pupil premium will support us in achieving our vision.

## **Principles**

- We seek to ensure that teaching and learning opportunities meet the needs of all of the pupils:
- We seek to ensure that appropriate provision is made for pupils who belong to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed;
- In making provision for socially disadvantaged pupils, we recognise that not all pupils who receive free school meals will be socially disadvantaged;
- We also recognise that not all pupils who are socially disadvantaged are registered or qualify for free school meals. We reserve the right to allocate the Pupil Premium funding to support any pupil or groups of pupils the school has legitimately identified as being in need of intervention and support;
- Pupil premium funding will be allocated following a needs analysis which will identify priority classes, groups or individuals.

#### **Provision**

The range of provision the staff and governors consider making for this group include:

- Reducing class sizes thus improving opportunities for effective teaching and accelerating progress;
- Providing 1-1 and smaller group work with an experienced teacher focused on overcoming gaps in learning;
- Additional teaching and learning opportunities provided through learning mentors, trained TAs or external agencies;
- The majority of our work through the pupil premium will be aimed at accelerating progress moving children to at least age related expectations. Initially this will be in communication, English and Maths:
- In addition, the school recognises that the wider curriculum supports and enriches children's development in communication, English and maths, and therefore funding will also be allocated to enable children to participate fully and actively in wider and extra-curricular activities;
- Pupil premium resources may also be used to target able children on Free School Meals to achieve more than expected age related progress.
- Provision will not be aimed at children who have a Statement / EHCP as funding for need is already in place.

# Reporting

- It will be the responsibility of the Head Teacher and Deputy Head Teacher who is the delegated member of staff, to report to the Governors on:
  - the progress made towards narrowing the gap, for socially disadvantaged pupils;
  - o an outline of the provision that was made since the last meeting;
  - an evaluation of the cost effectiveness and impact of the provision in terms of the progress made by the pupils receiving a particular provision.
- The Pupil Premium Champion, Mrs Golding, will lease with teachers and teaching assistants termly to update the pupil premium children's portfolios regarding attainment, interventions and any other provision the children are receiving.
- Parents will receive information as to the progress of pupils through termly parent interviews and through reporting of assessment results at the end of the academic year.

• The Governors of the school will ensure that there is an annual statement available to parents on how the Pupil Premium funding has been used to address the issue of 'narrowing the gap', for socially disadvantaged pupils.

This task will be carried out within the requirements published by the Department for Education and will appear on our school website.
